NARRATIVE: ON 04-09-2011 AT APPROX. 2051 HRS DEPUTY COPELIN WAS DISPATCHED TO THE ABOVE LISTED RESIDENCE IN REFERENCE TO DISTURBANCE. UPON ARRIVAL DEPUTY COPELIN MADE CONTACT WITH THE COMPLAINANTS, MICHAEL AND SHANDI SVATEK. SHANDI SVATEK STATED THAT HER AND HER HUSBAND, MICHAEL SVATEK, HAD AN ARGUMENT EARLIER IN THE EVENING AND SHE HAD DECIDED TO GO STAY WITH HER FATHER, JODY WILLIAMS (W/M DOB 05-09-1961). SHANDI CONTACTED WILLIAMS WHO CAME OVER TO THE RESIDENCE. DURING THE TIME THAT WILLIAMS WAS EN ROUTE TO THE RESIDENCE, MICHAEL AND SHANDI WORKED OUT THEIR PROBLEMS, AND WERE NO LONGER IN AN ARGUMENT. UPON WILLIAMS ARRIVAL, HE WAS ACCOMPANIED WITH HIS GIRLFRIEND, UNKNOWN NAME, AND AN UNKNOWN BLACK MALE. WILLIAMS ARRIVED AND STARTED THREATENING MICHAEL WITH INJURY. STATING THAT HE WAS GOING TO JUMP ON WILLIAMS. SHANDI, WHO WAS OUTSIDE HOLDING HER SON, PATRICK HARVEY SVATEK, TRIED EXPLAINING TO WILLIAMS THAT EVERYTHING WAS OK NOW. WILLIAMS STILL CONTINUED TO BE THREATENING. WILLIAMS TOLD MICHAEL THAT HE HAD A GUN IN THE CAR. WILLIAMS THEN EXITED HIS VEHICLE, AND TOLD BOTH SVATEK THAT HE WAS TAKING HIS GRANDSON WITH HIM. SHANDI WAS STILL HOLDING THE CHILD AT THIS TIME. WILLIAMS WALKED UP TO SHANDI AND GRABBED THE CHILD AND TRIED TO PULL THE CHILD FROM HIS MOTHERS ARMS. MICHAEL THEN RAN INTO THE RESIDENCE, RETRIEVED HIS .40 CAL HANDGUN, WENT INTO THE BACK YARD AND FIRED TWO ROUNDS. WILLIAMS, AND THE OTHER SUBJECTS WITH HIM, THEN GOT BACK INTO THE VEHICLE, DESCRIBED AS AN OLDER MODEL BLACK DODGE DAKOTA, AND DROVE AWAY. WILLIAMS LEFT AND HEADED BACK TOWARDS NACOGDOCHES. AT THE TIME OF THE INJURY TO THE CHILD, NO INJURIES COULD BE SEEN ON THE CHILD. AFTER MAKING CONTACT WITH THE COMPLAINANTS ON 04-10-2011 AT APPROX. 1439 HRS, DEPUTY COPELIN WAS SHOWN THE MARKS ON THE CHILD. THE CHILD HAD A BRUISE ON HIS RIGHT UPPER ARM, JUST ABOVE THE ELBOW. JUST ABOVE THE BRUISE WAS AN APPARENT HAND MARK WERE THE ARM WAS SQUEEZED. DEPUTY COPELIN DOCUMENTED THE INJURIES WITH PHOTOS. SVATEK STATED THAT HE DID NOT WANT WILLIAMS BACK ON THE PROPERTY. DEPUTY COPELIN ATTEMPTED TO MAKE CONTACT WITH WILLIAMS AND ISSUE A
