On 6-6-11 this Deputy Constable Russell Wright was dispatched to 877 FM 95 N in reference to a physical disturbance in progress. Upon arrival this deputy made contact with the actors, Kameron Jackson W/F 12-5-88 and Penny Jo Franklin W/F 8-8-72, who stated that there had been a physical fight with each other. This deputy noticed Jackson bleeding from the bridge of her nose. This deputy did not notice any apparent injuries to Franklin. Jackson stated that prior to this deputies arrival she passed out possibly due to the heat. This deputy contacted dispatch and advised them to send EMS to respond to the scene. While waiting for EMS, this deputy conducted interviews with both parties. Jackson and Franklin both stated that the altercation started out verbal only and then turned physical. Neither party wished to file charges on the other. This deputy had both parties fill out statements of non-prosecution. This deputy also photographed Jackson's injuries as well as Franklin's cheek ( where she stated she was hit by Jackson). This deputy gave both parties a Notice to adult victims of family violence card. Upon EMS arrival, Jackson was checked out and refused transport to the hospital. Both parties were separated and at this time, this deputy went back in service. Both statements of non-prosecution will be attached to this report. EOR
