## Property Destruction Investigation Narrative

1. Brief description of the offense: The Complainant advised that on the morning of 07/19/2011 she had instructed her adult son to leave her residence, at which time he became belligerent and combative towards her. The defendant physically assaulted her and used his fist to strike the thermostat at her residence, causing the thermostat to break. The defendant also threw an object that had been located at a coffee table in the residence and struck two light fixtures, causing the switch plate covers to break and the light switches to be pushed into the wall opening. The Complainant advised that these acts were witnessed by her sister and the Nacogdoches Police Department was called to the scene.

The defendant was arrested by the Nacogdoches Police Department for the "C" Misdemeanor Assault (Family Violence), but not the Criminal Mischief. The defendant was placed in the Nacogdoches County Jail and a temporary protective order was also issued against the defendant by Judge Springer.

On 07/22/2011 the Complainant contacted Sheriff Kerss after speaking with the County Attorney's Office and seeking a full Protective Order against her son, the defendant. The complainant explained the details of the disturbance to Sheriff Kerss and advised that the Police Department had declined to file charge of Criminal Mischief against her son for the damage he intentionally caused to her residence. The Complainant produced a receipt from Piney Woods Refrigeration showing the repair of the thermostat to have cost the Complainant \$108.00. She also estimated the two switch covers that were damaged to have been valued at approximately \$4.00 each and a glass fixture that was broken to have been valued at approximately \$5.00.

Based on the fact that the Complainant had reliable information proving her son, defendant Eric Wilson, had intentionally and knowingly damaged her residence without her consent and the damage caused to her residence exceeded \$50.00 in value, but was less than \$500.00 in value, Sheriff Kerss believed probable cause did exist to charge the defendant with "B" Misdemeanor Criminal Mischief. Because the defendant was currently in custody in the Nacogdoches County Jail no warrant was necessary and the charge of Criminal Mischief was added to the defendant's charges. The defendant was also served with notice of a hearing from Judge Sinz Court regarding a motion on a full protective order.
