ON Tuesday 11-15-2011 DEPUTIES RESPONDED TO A POSSIBLE MAJOR ACCIDENT INVOLVING A PEDESTRIAN AND TRAIN ON CR. 206. COMPLAINANT WHO WAS OPERATING A UNION PACIFIC TRAIN ADVISED HE SAW A WHITE MALE WEARING A REDISH COLOR SHIRT LAYING ON THE SIDE OF THE RAILROAD TRACKS. UPON ARRIVAL DEPUTIES BEGAN FOOT PATROL IN THE NORTH BOUND DIRECTION OF THE RAILROAD TRACKS. AFTER TRAVELING APPROX 1.5 MILES DEPUTIES ENCOUNTERED A WHITE MALE IN A RED SHIRT FITTING THE DESCRIPTION OF THE POSSIBLE VICTIM IN THE ACCIDENT.
