
1. Public comment.

5. Discuss and possibly take action concerning declaring items within the Nacogdoches County Sheriff's Office as salvage in capital assets and to authorize disposition of said items.
6. Discuss and possibly take action concerning consideration of the County to enter into an agreement with Motor Jam Productions for the Demolition Derby to be held at the Nacogdoches County Exposition Center on April 21, 2012.
