They advised that they were assaulted and the vehicle was struck by a bottle on CR 122. They advised that the vehicle had left traveling south on Hwy 259 and it had temporary tags. No other information was given. Deputy was UTL on the vehicle.

At approximately 0352 hours, the Complainant contacted dispatch and advised they had located the vehicle, but lost it on Powers Street. Dispatch advised then to come to the LEC to file a report. As of 1700 hours, they had not showed. Dispatch attempted to contact Complainant by telephone but there was no answer.
