On Monday March 26, 2012 at approximately 1830 hours a Deputy was dispatched to North St. in regards to an incident that occurred in the county. The Deputy arrived on scene and after interviewing the complainant learned that the incident had already been reported and investigated. The complainant was not satisfied with the Child Protective Service investigation. The Deputy told the complainant that the Sheriffs Office did not supervise CPS. The complainant asked what she should do if her daughter made another outcry. The Deputy told the complainant to report any instance of child abuse to the law enforcement.
