THE COMPLAINANT WAS UNSURE OF HOW THE HOME OWNER WOULD REACT BY SEEING THEM ON HER PROPERTY DUE TO BAD PAST HISTORY BETWEEN THE TWO OF THEM. THIS DEPUTY WAS ABLE TO MEDIATE THE IMMEDIATE DISPUTE BETWEEN THE TWO OF THEM AND THE COMPLAINANTS BELONGINGS WERE RETURNED TO HIM WITHOUT INCIDENT. EOR
