UPON ARRIVAL TO THE RESIDENCE, CURTIS CONTACTED TWO OCCUPANTS, A MALE AND A FEMALE. THE MALE IMMEDIATELY STATED "SHE GONE NOW". CURTIS ASKED HIM WHO HE WAS TALKING ABOUT AND HE ADVISED A FEMALE COMPANION THAT WAS BASICALLY JEALOUS OF ANOTHER RELATIONSHIP THAT HE WAS INVOLVED IN. THE MALE SUBJECT WENT ON TO STATE THAT THE FEMALE FRIEND CUT HERSELF ON THE ARM TWO DAYS PRIOR WITH A MACHETE IN SHELBY COUNTY. HE WENT ON TO STATE THAT THE CUT WAS ABOUT 4 INCHES LONG AND AT LEAST 1/2 INCH DEEP. HE ADVISED THAT HE INSISTED THAT SHE GO TO THE EMERGENCY ROOM BUT SHE REFUSED TO DO SO. HE STATED THAT HE USED "STERI STRIPS" TO CLOSE THE WOUND UP FOR HER. HE ADVISED THAT THE SITUATION WAS NOT REPORTED TO SHELBY COUNTY BY ANYONE AT THE TIME. THE MALE STATED THAT TODAY SHE RETURNED TO THIS RESIDENCE AND WAS CAUSING A DISTURBANCE. HE STATED THAT SHE MUST HAVE CALLED 911 WHEN SHE LEFT. THE MALE SUBJECT GAVE CURTIS THE FEMALE SUBJECTS PHONE NUMBER WHICH WAS MATCHED TO THE 911 CALL. THE MALE STATED THAT HE DOES NOT WANT HER BACK AT THIS RESIDENCE. CURTIS ATTEMPTED TO CONTACT HER BY PUBLIC SERVICE, BUT THE MESSAGE STATED THE CALLER IS NOT RECEIVING CALLS AT THIS TIME.
