I observed the waterline being repaired. Jimmy Partin provided a written statement that stated "James F. Holbrook tore up the waterline in my yard. I ask him about the waterline and he said he broke it."

Sherita stated that Holbrook was getting violent due to his mental condition. I told her to contact BP 1 for information on a mental health warrant. Deputies S. Landeros and S.
