ON 11-22-12, OFFICER DAVIDSON WAS DISPATCHED TO THE LEC TO CONTACT COMPL IN REFERENCE TO A POSSIBLE CHILD CUSTODY DISPUTE. UPON ARRIVAL, OFFICER MADE CONTACT WITH THE COMPL AERYAL HEWITT. SHE ADVISED THAT SHE HAS A FIVE YEAR OF AGE DAUGHTER THAT HER EX BOYFRIEND, RICKY MARTIN CURRENTLY HAS POSSESSION OF AND WONT RETURN THE CHILD TO HER SO SHE CAN LEAVE FOR SAN ANTONIO IN THE MORNING. SHE ADVISED ON THIS DATE AT APPROX 1500 HRS, RICKY MET UP WITH AERYL IN CENTER AND AERYL LET RICKY HAVE THE CHILD. ALYSON MARTIN. FOR THE THANKSGIVING HOLIDAY WITH THE INTENTION THAT HE BRINGS THE CHILD BACK THIS SAME DATE BUT HASN'T AND WONT RETURN PHONE CALLS. AERYAL ADVISED THAT RICKY IS NOT THE FATHER OF THE CHILD BUT GAVE THE CHILD HIS LAST NAME, MARTIN, ON THE BIRTH CERTIFICATE.
