On Tuesday, November 27, 2012 I (Sheriff Thomas Kerss) was contacted by the complainant, Lenard Sowell, who advised that a small coin purse containing his wife's driver's license, her insurance card (Blue Cross/Blue Shield) and her medicare card had either been lost or stolen. Mr. Sowell advised that he had accompanied his wife, Lutherine, to a doctor visit at Dr. Lehman's Office on the morning of 11/26/2012 and the information had been used at that appointment. Sometime after the information was presented to Dr. Lehman's office attendant (approximately 0700) and the time they returned home (approximately 0800)the purse and contents went missing.
