McQueen and his wife have been nursing his mother-in-law until she died of natural causes about a week ago. He is named as executor to her estate and lives just around the corner from her residence which is 769 CR 116. The entire family has been getting the house situated and has even helped the suspect Johnson get some things out of her house. Today, Johnson called him and asked why McQueen was over at "his" mothers house. McQueen and his wife were there cleaning. Suspect, Johnson, then told him NOT to go over there again and they began arguing over the phone. Suspect, Johnson, then advised McQueen that he was going over to "his" mothers house and if he is there, Johnson will kill him.

McQueen, knowing that Johnson has a tendency for violence toward family member, is afraid for his life. McQueen also knows that Johnson has been in jail several times for family violence toward other family member, including his own children. McQueen requested that charges for terroristic threat be filed at this time.
