AT APPROXIMATELY 1330 HRS CAPTAIN BROWN CONTACTED DEPUTY MASTEN IN THE CONTROL ROOM OF THE NACOGDOCHES COUNTY JAIL AND ADVISED THAT INMATE TIEROD SWEAT HAD STOLEN A BAG OF COMMISSARY.

CAPTAIN BROWN STATED THAT ON April 25, 2013 BETWEEN 1315HRS AND 1320 HRS COMMISSARY WAS BEING PASSED OUT IN THE HALLWAY OF THE NACOGDOCHES COUNTY JAIL. BROWN ADVISED THAT INMATE SWEAT AFTER RECEIVING HIS COMMISSARY WAS ON IS WAY DOWN THE HALLWAY TO HIS BLOCK WITH HIS COMMISSARY, WRAPPED IN A BED SHEET, WHEN KAYLA MITCHELL, NACOGDOCHES COUNTY JAIL EMPLOYEE, STATED TO BROWN THAT SWEAT HAD PICKED UP SOMEONE ELSE'S COMMISSARY BAG ALONG WITH HIS OWN COMMISSARY. BROWN ADVISED THAT SHE TOLD SWEAT TO STOP IN THE HALLWAY AND TO PLACE HIS COMMISSARY ON THE GROUND. BROWN STATED THAT SWEAT PLACED HIS COMMISSARY ON THE GROUND AND THAT A UNOPENED PLASTIC BAG CONTAINING COMMISSARY FOR INMATE KYLE MCKELVEY SPILLED FROM THE BEDSHEET ONTO THE FLOOR. WHEN ASK ABOUT THE UNOPENED COMMISSARY SWEAT REPLIED TO BRWON THAT HE DID NOT KNOW WHERE IT CAME FROM AS HE ONLY HAD HIS OWN COMMISSARY. THE COMMISSARY PURCHASED BY MCKELVEY HAD NOT YET BEEN PASSED AND WAS INSIDE CORRUGATED BOXES AGAINST THE WALL IN THE HALLWAY WITH OTHER BAGS OF COMMISSARY WAITING TO BE PASSED.

BROWN CONFISCATED THE UNOPENED COMMISSARY WHICH CONTAINED TWO 3 OZ PACKAGES OF KEEFE COFFEE, ONE PACKAGE OF E.Z. DIGBY'S SOUR FRIUT BALL CANDY AND SIX LARGE STAMPED ENVELOPES. TOTAL COST \$14.10.
