On Saturday, 04-12-14, at approximately 1600 hours, NCSO Deputies were dispatched to a deadly conduct call that occurred on CR 521. Upon arrival deputies discovered that a h/m, who was on foot began firing several rounds at a white passenger vehicle that was passing by. Deputies believe the windows were struck on the vehicle, causing the windows to shatter. The subjects in the vehicle and the suspect fled the scene prior to deputies arrival. The incident occurred in front of several houses where children were playing outside. Deputies went to a residence near by where the suspect was believed to have fled. Upon arrival at the residence two h/m fled from deputies on foot. The suspect in the shooting was apprehended after he fled across several yards, jumped several fences and attempted to hide inside of a residence from deputies. This subject was arrested for deadly conduct, evading arrest, and transported to the Nacogdoches County Jail without further incident.
