## NCSO Narrative

On 04-09-14 at approximately 2230 hours, while a NCSO Deputy were patrolling the Etoile Community, this deputy observed a vehicle driving recklessly in the 7000 Block of CR 445. This deputy attempted to conduct a traffic stop on the vehicle. The suspect began fleeing from deputies for several miles, while losing control and leaving the roadway on numerous occasions.
