INTRODUCTION: DAVIDSON 514

ON 12-25-14, DEPUTIES WITH THE NACOGDOCHES COUNTY SHERIFF'S OFFICE WERE ADVISED THAT DPS LUFKIN WAS IN A PURSUIT OF A STOLEN VEHICLE AND WAS ENTERING NACOGDOCHES COUNTY. DURING THE PURSUIT, DPS HAD LOST SIGHT OF THE VEHICLE ON FM 225 NEAR LAKE NACOGDOCHES. DEPUTIES FROM NACOGDOCHES SHERIFF'S OFFICE OBSERVED THE VEHICLE AND BEGAN TO ENGAGE THE VEHICLE WERE THE DEPUTY LOST SIGHT OF THE VEHICLE AGAIN. A PERIMETER WAS SET UP AND THE VEHICLE WAS OBSERVED AGAIN UNATTENDED ON CR 769. THE SUSPECT HAD LEFT THE VEHICLE AND WENT TO A RESIDENCE WITH A FIREARM WHERE HE TALKED SUBJECTS THERE INTO GIVING HIM A RIDE. THE DRIVER OF THE VEHICLE BECAME SUSPICIOUS AND EXITED THE VEHICLE WHERE THE SUSPECT THEN JUMPED INTO THE DRIVER SEAT AND ATTEMPTED TO LEAVE IN THE VEHICLE BUT WAS BEING RESTRAINED UNTIL DEPUTIES ARRIVED ON SCENE AND PLACED HIM INTO CUSTODY AFTER A BRIEF STRUGGLE. DEPUTIES LEARNED THAT WHILE DEPUTIES HAD SET UP THE PERIMETER, THE SUSPECT HAD BROKEN INTO A RESIDENCE AND A VEHICLE WHERE A PISTOL HAD BEEN TAKEN.
