# MINUTES Regular Session Nacogdoches City Council February 3, 2015 – 5:30 p.m. City Council Room – City Hall 202 E. Pilar Street



#### **Regular Session:**

#### **Those Present:**

Mayor Roger Van Horn; Council members Shelley Brophy, Roy Boldon, Mike Keller and David Norton; City Manager Jim Jeffers, City Attorney Rob Atherton and City Secretary Lila Fuller.

#### 1. Call to Order.

Mayor Van Horn at 5:30 p.m. A quorum was established.

#### 2. PRESENTATIONS AND RECOGNITIONS:

Mayor Van Horn announced that there would be no public comment regarding meeting invocations.

Mayor Van Horn asked for a moment of silence.

3. Items to be removed from Consent Agenda.

C. Receive guarterly investment report for Quarter ended December 31, 2014.

D. Consider a Resolution authorizing submission of a grant application for 2015-2016 Texas Community Development Block Grant program, and authorizing the City Manager to act as the Executive Officer and Authorized Representative in all matters pertaining to the participation in the Texas Community Development Block Grant Program.

Council member Boldon moved to approve the consent agenda as presented. The motion was seconded by Council member Norton and unanimously passed.

## 5. Reconsider selection process for Convention and Visitors Bureau board members.

City Manager Jim Jeffers explained the selection process was previously approved with an interview committee consisting of the city manager, HR director and one city council member authorized by the city council. Jeffers stated those selected to serve on the interview committee were himself, Stephen Pearl and Council member Shelley Brophy. He further stated Council member Norton has asked that this item be revisited.

Mayor Van Horn recognized Council member Norton who stated he asked to sit in on the interviews and was told he could not. He stated he did not like that the selection was taken from the City Council and wanted to return to the policy of full council selecting the CVB.

Council member Norton moved to revert back to full City Council selecting the CVB Board members like all other boards. There being no second, Mayor Van Horn declared the motion having died for lack of second.

Mayor Van Horn stated the basis for the policy change was because the CVB Board was responsible for money, unlike the other boards.

#### 6. Receive update on Big Nac Music Festival.

Sarah O'Brien, main street manager, gave a brief update on the Big Nac Music Festival scheduled for March 5-7. She stated Pilar Street would be closed for use of the Plaza stage and a full slate of events was planned.

John Niss with Texas Music Magazine appeared and gave further information on the event. He said they planned to use Liberty Bell, Mast Hall, Banita Creek Hall and the Mill Room at Banita Creek Hall as venues. He further stated there would be free shows throughout the day with student and SFA Alumni discounts offered for the evening performances.

The council voiced their appreciation to Mr. Niss on choosing Nacogdoches to hold this event.
