Regular Session:

Those Present:

Mayor Pro Tem Keller; Council members Shelley Brophy, Roy Boldon and David Norton; City Manager Jim Jeffers, City Attorney Rob Atherton and City Secretary Lila Fuller.

1. Call to Order.

Mayor Pro Tem Keller at 5:30 p.m. A quorum was established. Mayor Van Horn had an excused absence.

2. Canvass results of May 9, 2015 City Council election and administer Oath of Office to newly elected City Council members.

City Secretary Lila Fuller presented the unofficial results of the May 9 election for the Northeast Ward and Northwest Ward Council members as follows:

Jo Ellen H. Carlson 56

Northeast Ward

Terry Courtney 79

Shelley Brophy 313

Ms. Fuller stated the action needed by the City Council was to canvass the results and adopt a Resolution declaring the results official and confirming the election of Mike Keller, City Council member Northwest Ward and Shelley Brophy, City Council member Northeast Ward. Ms. Fuller also reminded the Council that even though the Mayor Van Horn was shown on the ballot as required by law, he ran unopposed and was previously declared the winner.

Council member Norton moved that a Resolution be adopted canvassing the results of the May 9, 2015 City Council election and declaring Mike Keller, City Council member Northwest Ward and Shelley Brophy, City Council member Northeast Ward winners as presented. The motion was seconded by Council member Boldon and unanimously passed.

City Attorney Rob Atherton administered the Oath of Office to Council members Keller and Brophy.

Council member Brophy moved to approve the consent agenda as presented. The motion was seconded by Council member Boldon and unanimously passed.

REGULAR AGENDA:

6. <u>PUBLIC HEARING</u>: Consider the request for a zoning change from B-1, Local Business t B-2, General Business for Lots 1 & 2, C.L. Simon No. 1 Subdivision, City Block 64 located on the southeast corner of Woden Road and SE Stallings Drive. This request was initiated by Thary Por. ZON2015-002.

Larissa Philpot, city planner, explained that the property was currently zoned B-1 and the property owner was planning to construct a donut shop at this location. However, the drive-thru planned for the building is not allowed in a B-1, therefore the B-2 zoning was requested. Ms. Philpot stated the surrounding businesses were better suited for B-2 and the Planning and Zoning Commission recommends that staff bring forward for consideration in the future rezoning other commercial property in the area to reflect current development.

Ms. Philpot also stated that the business will have to create a buffer between the business and residential properties as required. She further stated no one appeared at the Planning and Zoning Commission meeting to speak in opposition of the request. When asked, Ms. Philpot stated all property owners living within 200 feet of the proposed property had been notified as required.

Mayor Pro Tem Keller opened the public hearing.

Charles Hartt with 3D Construction appeared representing the property owner. He stated the property owner purchased the property with the intent to construct a donut shop at this location. He explained he had been the contractor for several other donut shops in Nacogdoches and stated they were all quality stores.

Ruby Davis, 2702 Sharon Drive, appeared and stated she lived outside of the 200 feet, but has concerns of other businesses being constructed in this area if the zoning was changed. She stated she was concerned about traffic and did not want businesses on this corner as proposed.

Norma Moore, 2714 Sharon Drive, appeared and stated she wanted to keep the neighborhood residential and if the zoning was changed to B-2, then other businesses would come in. She stated it was in the best interests of the subdivision for it to remain residential.

Cal Wallace, adjoining property owner to the property in questions, stated he did not want a business at this location.

Larissa Philpot clarified that the drive-thru is what triggered the zone change, and that the property was already zoned for business.

Billy Joe Fowler, Jr. appeared and stated the subdivision was residential and did not want a business next door.

Mayor Pro Tem Keller asked the property owner if she would still construct a donut shop at this location even if the drive-thru was not allowed and she stated she would.

There being no one else present desiring to be heard, Mayor Pro Tem Keller closed the public hearing.

Council member Brophy moved to deny the request for a zone change, stating she did not want spot zoning. Council member Boldon seconded the motion, stating he did not support spot zoning. On a call for the vote, the motion passed unanimously to deny the request.

7. Receive update on collection services conducted by the law firm of McCreary, Veselka, Bragg and Allen, PC for Municipal Court.

Laird Markland with McCreary Veselka, Bragg and Allen appeared and gave a brief update on the collection of delinquent fines and fees for the City of Nacogdoches Municipal Court. He stated they had collected over 2.2 million over the past five years at a 21% collection rate, which was outstanding. He stated the number of cases placed with his firm over the past several years had decreased due to the good job the Court staff was doing in collected within the first 90 days.

8. Consider budget amendment and approval to purchase a 1-ton dump bed, 4-door truck and $\frac{1}{2}$ ton truck for Parks Department.

Brian Bray, community services director, appeared stating they were requesting a budget amendment for 2 vehicles to be used for mosquito spraying/general duty and for the mowing crew for the Parks Department. He stated bids came in over budget and they were requesting a budget amendment of \$7,100 in account 60.60.680.20 to cover the difference.

Mayor Pro Tem Keller moved to approve the budget amendment in the amount of \$7,100 and authorize the purchase of 1-ton dump bed/truck and ½ ton truck for the Parks Department as presented. The motion was seconded by Council member Boldon and unanimously passed. (Ordinance No. 1698-5-15)

9. Consider annual appointments to the Deep East Texas Council of Governments (DETCOG) Board of Directors for one-year terms.

Mayor Pro Tem Keller stated Council members Brophy, Keller, Boldon and Norton were current serving on the DETCOG Board, and he moved that they continue to serve for another year. The motion was seconded by Council member Norton and unanimously passed.

10. Receive budget presentation.

City Manager Jim Jeffers explained the city manager's duty for budget development and reviewed the current property tax rates. He again emphasized the need for the city council and staff to find ways to increase revenue for the upcoming budget year.

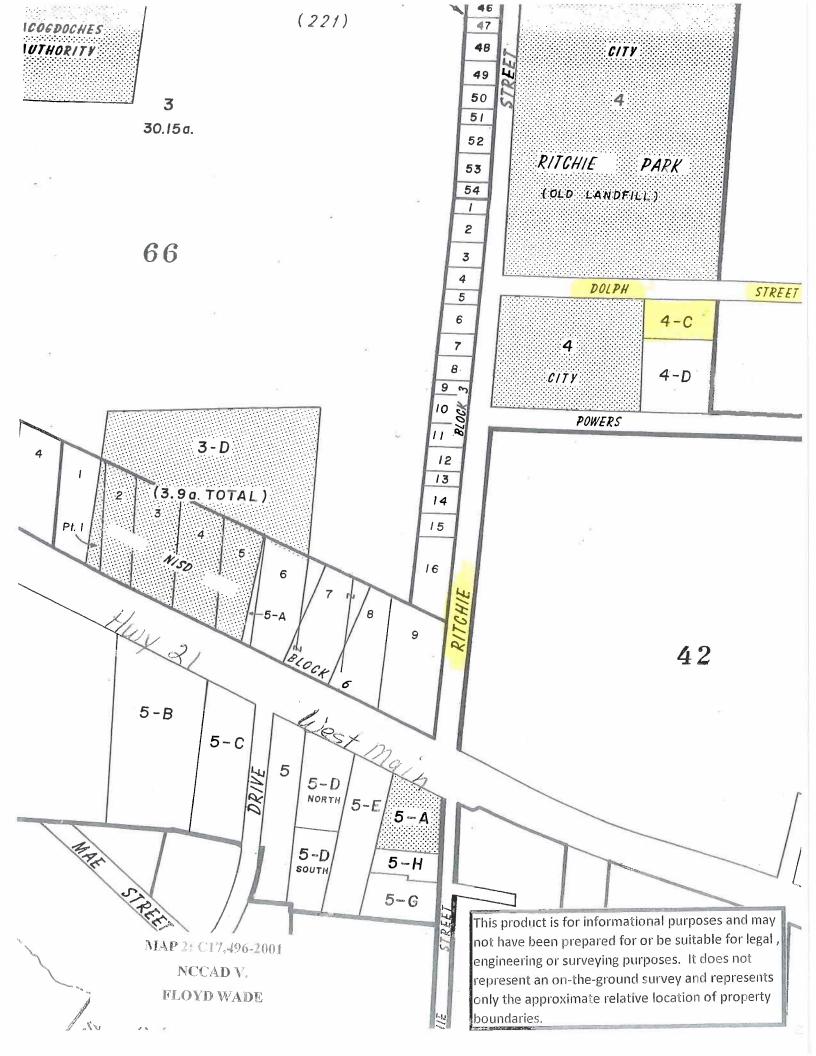

DESCRIPTION: In 1994 the City assisted Pilgrims (then Green Acres Foods) with a \$1.4

million economic development loan from the State. Essentially the City received the money and was deeded by Green Acres a small tract of land upon which a blast freezer was constructed. The land and freezer were leased back to the company for a 20 year term. Lease payments were sufficient to repay the loan over the life of the lease at which time the land and freezer would be deeded back to the company. This was the State's way of making a 0% interest loan which the City was responsible

to pay back if the company defaulted.

Pilgrims has repaid all but about \$35,000.00 of the loan, and the lease only has a few months to run. It recently refinanced its assets for \$1.7 Billion dollars and its lender wants the City to effectively subordinaate the lease to the new loan. In other words, if the bank forecloses on the loan it wants to be able to keep the lease and sell it, along with the rest

of the plant, to a new buyer.

This is not new in that the City did the same thing in 2009. We've worked with the Texas Department of Agriculture which now administers the contracts for the State, and it will sign off on the requested documents if the City does. Since the City is still on the hook for the remaining \$35,000.00, the State has no risk.
