ON 07/03/2015 AT APPROXIMATELY 2116 HOURS, NCSO DEPUTIES WERE DISPATCHED TO SHIRLEY CREEK BOAT RAMP IN REGARDS TO A DISTURBANCE. WHILE IN ROUTE DISPATCH ADVISED DEPUTIES THAT A MALE SUBJECT WAS DRIVING AN ATV RECKLESSLY AT HIGH RATES OF SPEED AROUND THE BOAT RAMP, WHILE IN ROUTE DISPATCH ALSO ADVISED DEPUTIES THAT TWO MALE SUBJECTS WERE FIGHT ON THE BOAT RAMP.
