5. Discuss and possibly take action concerning the adoption of the Nacogdoches County tax rate of \$0.5855 per \$100 of taxable value for the tax year 2015.

Discuss and possibly take action concerning ratification of the adoption of the 2015-2016 Nacogdoches County Budget which will raise **more** in property taxes than last year's budget by **\$1,498,787 or 9.45%**, and of that amount **\$253,051** is tax revenue that will be raised from new property added to the tax roll this year.

11. Discuss and possibly take action concerning acceptance of fiscal year 2016 Appriss Maintenance Renewal Notice for Automated Victim Notification Services.


