# MINUTES Regular Session Nacogdoches City Council September 8, 2015 – 5:30 p.m. City Council Room – City Hall 202 E. Pilar Street



### **Regular Session:**

### **Those Present:**

Mayor Roger Van Horn; Council members Shelley Brophy, Roy Boldon, Mike Keller and David Norton; City Attorney Rob Atherton and City Secretary Lila Fuller.

1. Call to Order.

Mayor Van Horn at 5:30 p.m. A quorum was established.

### 2. PRESENTATIONS AND RECOGNITIONS:

- 3. Items to be removed from Consent Agenda.

- 4. <u>CONSENT AGENDA:</u> Items included under the Consent Agenda require little or no deliberation by the Council. Approval of the Consent Agenda authorizes the City Manager or his designee to proceed with conclusion of each in accordance with staff recommendations as reflected in the minutes of this meeting.
  - A. Consider approval of minutes from the regular session of August 18, 2015.

Approved as presented.

B. Consider contract award to Hydrex Environmental for landfill expansion study.

Approved as presented.

Council member Norton moved to approve the consent agenda as presented. The motion was seconded by Council member Keller and unanimously passed.

### **REGULAR AGENDA**:

5. Consider adopting FY 2015-2016 budget.

Pam Curbow, director of finance, gave highlights of the FY 2015-2016 budget, stating the budget was based on a proposed tax rate of \$0.5681 per \$100 valuation which would generate additional revenue of \$150,341. She reviewed the budget by fund, stating the City was able to fully fund depreciation this year.

There being no questions by the Council, Council member Norton moved to adopt the 2015-2016 annual budget for the City of Nacogdoches as presented. The motion was seconded by Council member Keller and unanimously passed. (Ordinance No. 1700-9-15)

Council member Boldon moved to ratify the property tax rate increase of \$150,341, reflected in the budget for the City of Nacogdoches for fiscal year 2015-2016. The motion was seconded by Council member Brophy and unanimously passed.

### 6. Consider ratification of 2015-2016 tax rate.

Pam Curbow, director of finance, revised the property tax rate as follows:

Council member Keller moved that the property tax rate be increased by the adoption of a tax rate of \$0.5681 per \$100 valuation, which is effectively a 0.74 percent increase in the tax rate. The motion was seconded by Council member Boldon and unanimously passed. (Ordinance No. 1701-9-15)

# 7. Consider entering into a Chapter 380 Economic Development Agreement between the City of Nacogdoches and Fredonia Hospitality, LLC.

Rob Atherton, city attorney, appeared and stated the City had been requested by Fredonia Hospitality, LLC (Richard DeWitt) for consideration of a City investment of hotel/motel tax for reopening of Fredonia Hotel and Convention Center. He reviewed the 380 agreement, which included reimbursement of hotel tax to Fredonia Hospitality, LLC in the amount of \$1,500.000 over a 10-year period to help mitigate start up costs and risks associated with reopening the convention center and hotel. Fredonia Hospitality, LLC commits to investing at least \$9,000.000 and employ at least 40 individuals. No City investment from the General Fund is included in the agreement.

Mr. Atherton briefly discussed Mr. DeWitt's pursuit of State tax incentives through legislation authorized by Representative Travis Clardy to allow investment of State tax money, which may require significant city involvement. He stated any participation in State tax incentives would be submitted for Council approval in the future.

Mayor Van Horn thanked Representative Clardy who was in attendance, and all of those in the community involved in getting this project developed thus far.

Larissa Philpot, city planner, briefly reviewed the economic analysis provided by NEDCO which indicating a benefit of over \$2 million over the 10-year period.

Council member Brophy moved to enter into a 380 Economic Development Agreement with Fredonia Hospitality, LLC as presented. The motion was seconded by Council member Norton and unanimously passed.

# 8. Consider approval of 380 Economic Development Agreement between the City of Nacogdoches and Eastern Fuel, LLC.

Steve Bartlett, city engineer, stated the City was proposing a 380 economic development agreement with Dr. J.T. Roberts for a travel center, fuel station, convenience store and Denny's restaurant, to be located on the southeast corner of N. Stallings and US 59. He stated the facility would employ 100 people (50 full-time equivalent) with an annual payroll of \$700,000. He stated Dr. Roberts had other similar properties in Henderson and Carthage.

Mr. Bartlett reviewed the terms of the 380 agreement that would provide a 5-year ad valorem tax rebate in consecutive years as follows:

Bartlett further stated the agreement also contained a sales tax situs clause, requiring Eastern Fuel, LLC to utilize a separated construction contract, and thus diverting all possible construction materials sales tax to Nacogdoches.

Council member Keller moved to approve the 380 Economic Development Agreement with Eastern Fuel, LLC as presented. The motion was seconded by Council member Boldon and unanimously passed.

# 9. <u>PUBLIC HEARING</u>: Consider annexation of approximately 35 acres west of current city limits at 3805 NW Stallings Drive.

Larissa Philpot, city planner, stated this was the first of two hearings to receive public comment on annexation of 35 acres located west of the current city limits at 3805 NW Stallings Drive, better known as the Exposition Center arena and barns owned by Nacogdoches County. She stated the next public hearing would be held on September 15, with final consideration of the annexation held on October 6.

Mayor Van Horn opened the public hearing.

There being no one else present, the public hearing was closed.

# 10. Consider recommendation to fill a vacancy on the Nacogdoches Convention and Visitors Bureau Board of Directors.

Council member Brophy, representing the Interview Committee consisting of herself, the city manager and the HR director, moved to appoint Shirley Luna to fill the unexpired term of Robin Land on the Nacogdoches Convention and Visitors Bureau Board of Directors. The motion was seconded by Council member Boldon and passed by the following vote:


