MINUTES Regular Session Nacogdoches City Council October 6, 2015 – 5:30 p.m. City Council Room – City Hall 202 E. Pilar Street



Regular Session:

Those Present:

Mayor Roger Van Horn; Council members Shelley Brophy, Roy Boldon, Mike Keller and David Norton; City Manager Jim Jeffers, City Attorney Rob Atherton and City Secretary Jan Vinson.

Mayor Van Horn called meeting to order at 5:30 p.m.

3. Items to be removed from Consent Agenda.

None.

- 4. <u>CONSENT AGENDA:</u> Items included under Consent Agenda require little or no deliberation by Council. Approval of Consent Agenda authorizes the City Manager or his designee to proceed with conclusion of each in accordance with staff recommendations as reflected in the minutes of this meeting.
 - A. Consider approval of minutes from September 8, 2015 special session and September 15, 2015 regular session.

Approved as presented.

B. Consider approval of 2016 Routine Airport Maintenance Program Grant.

Approved as presented.

Council member Brophy moved to approve the consent agenda as presented. Motion seconded by Council member Keller and unanimously passed.

REGULAR AGENDA:

5. Consider contract award for Depository Bank Services.

Pam Curbow, Finance Director, reported five (5) proposals were received. First Bank and Trust East Texas was determined to be the most advantageous for the City. The contract with First Bank and Trust will be for two (2) years with an option to renew three (3) additional one (1) year periods for a maximum of five (5) years.

Council member Keller moved to award the depository bank services contract to First Bank and Trust East Texas. Motion seconded by Council member Norton and unanimously passed.

6. Consider ordinance amending Chapter 34 "Environment" Article II. "Weeds and Other Offensive Accumulations" of the Code of Ordinance of the City of Nacogdoches, Texas.

Robert Ford, Fire Division Chief, stated the amended ordinance is simply clarifying the wording in the ordinance to aide enforcement. The property owner is responsible for maintaining areas in the right of way, between the sidewalk and curb of the road and areas which might not normally be considered lawn but are part of the property.

Council member Keller moved to approve amended ordinance as presented. Motion seconded by Council member Boldon and unanimously passed.

7. Consider award of Debt Collection Services Contract.

Pam Curbow, Finance Director, presented debt collection service contract primarily used for utility billing. Three (3) companies responded to the Request for Proposal with only two (2) completing the proposal process; Etech and Municipal Services Bureau (MSB). Staff from both Finance and Utility Billing reviewed the proposals and recommend MSB be used to provide debt collection services. MSB is the City's current debt collection service.

Council Member Boldon moved to award the debt collection services contract to Municipal Services Bureau (MSB). Motion seconded by Council member Brophy and unanimously passed.

8. Consider Convention and Visitors Bureau contract extension for tourism and convention marketing services.

Jim Jeffers, City Manager, stated the Convention and Visitors Bureau (CVB) Contract approval was deferred until after the first step in re-opening the Fredonia Hotel which was incentives from the City Council. The first \$150,000 per year generated in local hotel occupancy tax generated by the Fredonia Hotel will be rebated to the Fredonia Hotel due to contractual obligations with the owner of the Fredonia. The CVB has been retooled to focus on marketing and increasing hotel motel tax instead of event planning. CVB has approved the contract.

Council member Norton moved to approve CVB contract as presented. Motion seconded by Council Member Keller and unanimously passed.

9. Consider annexation of approximately 35 acres located west of the current city limits at 3805 NW Stallings Drive.

Final consideration of annexation presented by Larissa Philpot, Director of Municipal Services.

Council member Boldon moved to approve annexation of 35 acres located at 3805 NW Stallings Drive. Motion seconded by Council member Norton and unanimously passed.

10. Consider process for replacing retiring City Attorney.

Jim Jeffers, City Manager, requested direction on replacement process for City Attorney, Rob Atherton and presented options. Rob Atherton, City Attorney, will retire the last day of January 2016. Mr. Atherton offered his thoughts on the process to hire a City Attorney after his retirement.

City Council agreed unanimously that the process would be a statewide staff directed search for a full time in-house city attorney with Council interviewing finalist.

11. Consider authorization to purchase Asphalt Zipper 4' milling machine.

Cary Walker, Public Works Manager, discussed uses of a milling machine and projects the Street Department completed with a rented milling machine prior to this request for purchase. The Street Department budget is \$128,000 for the purchase of a milling machine. Actual purchase price of the Asphalt Zipper 4' milling machine is \$108,740.

Council member Brophy moved to approve purchasing the Asphalt Zipper 4' milling machine. Motion seconded by Council member Boldon and unanimously passed.

12. Consider authorization to purchase Kubota 108hp Tractor with Boom Mower.

Item tabled.

13. Consider approval for the purchase of five (5) patrol vehicles.

Jim Sevey, Police Chief, provided justification for purchasing five (5) new patrol vehicles for Nacogdoches Police Department through BuyBoard. Cost of purchasing

five (5) new patrol vehicles is \$173,775 of the \$300,000 budgeted for FY15/16. The remainder of the budgeted funds will be used to equip patrol vehicles.

Council member Norton moved to approve purchasing five (5) patrol vehicles for the Police Department. Motion seconded by Council Member Keller and unanimously passed.

DESCRIPTION: This property was originally zoned Agricultural in 1970. Surrounding

properties have been rezoned to R-4 over the years as the properties

have developed.

Surrounding properties on the east, west, and south are all zoned R-4, Multi-Family Residential. Properties in the surrounding neighborhood are a mix of Agricultural, Single Family Residential,

and Multi-Family Residential zoning.

COST: N/A

SCHEDULE: If the request for rezoning is approved, it will become effective 10

days after publication in the newspaper.

RECOMMENDED

ACTION:

The property owner spoke in favor of the request. No one else spoke

in favor of or in opposition to the request.

Planning and Zoning Commission unanimously recommended

approval of the request.

Conditions for approval to be considered (staff comments are

underlined):

(1) Compatibility. The specific use will be compatible with and not injurious to the use and enjoyment of other property in the immediate vicinity, nor significantly diminish or impair property

values within the immediate vicinity.

Changing the zoning of this property to R-4 will not diminish or impair property values in the area, and is compatible with the

surrounding land uses.

(2) Orderly growth and development. The establishment of the specific use will not impede the normal and orderly development

and improvement of surrounding vacant property.

The proposed zoning will not permit uses that would impede the orderly development and improvement of surrounding vacant property.

- (3) Supporting facilities. Adequate utilities, access roads, drainage and other necessary supporting facilities have been or will be provided.
 - Adequate supporting facilities already exist for the property, or can be provided with existing city policies.
- (4) Drives and parking. The design, location and arrangement of all driveways and parking spaces provided for the safe and convenient movement of vehicular and pedestrian traffic without adversely affecting the general public or adjacent developments.

 <u>Driveways currently exist for the properties. Any new driveways will have to comply with the City's driveway policies.</u>
- (5) Nuisances. Adequate nuisance-prevention measures have been or will be taken to prevent or control offensive odor, fumes, dust, noise, and vibration.
 - No nuisances are expected from the land uses permitted in an R-4 district.
- (6) Lighting. Any lighting to be provided will be directional so as not to disturb or adversely affect neighboring properties.

 The city's lighting ordinance will apply.
- (7) Landscaping. Sufficient landscaping and screening to ensure harmony and compatibility with adjacent properties exists or will be provided.
 - The city's landscaping ordinance does not apply to residential zoning districts.
- (8) Comprehensive plan. The proposed use is in accordance with the comprehensive plan.

The comprehensive plan recommends residential development for this area.



According to the Tax Code, I am required to send this request for nominees to you before the first of October in odd numbered years. There are five positions open on the Board of Directors and you may nominate up to five potential candidates. Your nominees must be as a result of a Resolution approved by your Governing Body. This list of nominees is to be returned to me by October 25, 2015. I will then create a ballot of all nominees timely received and return to you an actual ballot. Along with the ballot will be the calculated number of votes you may use in casting your ballot. This is to be returned to you by October 31, 2015. You will then cast your votes (splitting them as you wish among the candidates you wish to vote for) by Resolution of your Governing Body and return the results to me by December 27, 2015. Upon receipt, I will count the ballots and determine the top five candidates. I will return the results of the new members to the Board of Directors for the Appraisal District to you by December 30, 2015. The new Board will be sworn in at the first meeting in January, 2016.
