On 01-26-16 at approximately 2155 hours, a NCSO Deputy observed a passenger

vehicle commit a traffic violation in the 2000 block of SW Stallings Dr. A traffic stop was initiated and the vehicle came to a stop on Harris Dr. The driver was contacted and a strong odor of marijuana was observed omitting from the vehicle. While speaking with the driver, he was observed attempting to dispose of a green leafy substance believed to be marijuana, by eating it. A probable cause search of the vehicle was conducted. The search resulted in the seizure of more substance believed to be marijuana. He was arrested for misdemeanor and felony charges. He was transported to the Nacogdoches County Jail without further incident.
