On 02/29/16 at approximately 0730 hours, Deputy Wright was observing the north bound traffic on 259 in the Central Heights school zone. This deputy saw a white car traveling faster than the posted speed limit and activated the front moving radar and saw that the vehicle was traveling 59mph in a 35 mph zone. This deputy activated her red and blue emergency lights at FM 698 and the vehicle came to a stop in the parking lot of Polks on 259. Through a computerized check of the vehicle, this deputy learned that there was no insurance. This deputy asked the owner, Jerika Wright (B/F 12/21/92) if she had proof of insurance but said "no, it's in their other vehicle." Due to our department policy, any vehicle without insurance is to be removed from the roadway. This deputy contacted dispatch and asked for a rotation wrecker. The vehicle was inventoried and the sheet will be attached to this case. A short time later, Hopkins Towing arrived and took possession of the vehicle. Wright and driver, Jadarius Smith (B/M 09/30/1990) stayed at the convenience store until someone could come pick them up. Jadarius was written a citation for Failure to maintain financial responsibility. No further incident.
