Upon identifying them, it was found that the driver gave false information. During a search of the vehicle a felony amount of narcotics were located. After further investigation, more narcotics were found to be concealed in one of the occupants underwear. Both occupants were arrested on felony drug charges and transported to the Nacogdoches County Jail without further incident.
