OFFICER WAS WORKING TRAFFIC ENFORCEMENT AND NOTICED A POSSIBLE ACCIDENT OCCUR. ONE VEHICLE INVOLVED IN THE ACCIDENT DID NOT STOP AS REQUIRED. OFFICER PURSUED THE VEHICLE THAT LEFT THE SCENE OF THE ACCIDENT. THE DRIVER DID NOT YIELD TO OFFICER'S EMERGENCY EQUIPMENT AND CONTINUED LEADING OFFIER'S ON A PURSUIT. OTHER AGENCIES ASSISTED WITH THE PURSUIT WHICH WAS TERMINATED AT THE COUNTY LINE WITH THE DRIVER BEING PLACED INTO CUSTODY. THE DRIVER APPEARED HIGHLY INTOXICATED AND WAS TRANSPORTED TO A LOCAL HOSPITAL.
