Deputy was dispatched to a theft of automobile at 2400 Block of CR 555. Deputy spoke with complainant, who stated her roommate borrowed her car without her permission. Complainant just wanted him not to borrow the car without her consent. Deputies spoke with the roommate, who stated he did not have permission to borrow the car like he usually does. The initial call was resolved. Deputies identified a third subject on scene who had two warrants out NPD.
