PC 30.02 BURGLARY OF A HABITATION SJF

ON 4-21-20 AT AROUND 0938 HRS I, OFFICER BELL, RESPONDED TO 1231 VICTORIA DR IN REFERENCE TO A FOLLOW UP INVESTIGATION TO CASE #P20-05967 WHERE MULTIPLE VEHICLES IN THE AREA HAD BEEN BURGLARIZED. ON THE NIGHT OF 4-19-20, TWO SUBJECTS, SHANNON STARKEY WF 2-16-86 AND HANNAH MITCHELL WF 10-2-98, WERE TAKEN INTO CUSTODY FOR OTHER OFFENSES AND FOUND TO BE IN POSSESSION OF PROPERTY THAT HAD BEEN STOLEN DURING THE VEHICLE BURGLARIES. SOME OF THE PROPERTY THAT WAS RECOVERED WERE DEPOSIT SLIPS AND A PAY STUB.

THE DEPOSIT SLIPS BELONGED TO DAVID NEESE WM 5-13-73 AND THE PAY STUB BELONGED TO HIS SON, JACOB NEESE WM 3-6-01. AT THIS TIME I WAS ABLE TO MAKE CONTACT WITH DAVID AND JACOB AT 1231 VICTORIA DR. JACOB STATED THAT ON 4-20-20 HE NOTICED THAT ONE OF THE DOORS TO THEIR 2018 TOYOTA RAV 4 (TX LP LDV1622) WAS LEFT SLIGHTLY AJAR. HE ADVISED THAT HE SHUT THE DOOR UNDER THE ASSUMPTION THAT HIS PARENTS LEFT IT OPEN BY ACCIDENT. DAVID'S WIFE ALSO ADVISED THAT THE CENTER CONSOLE AND GLOVE COMPARTMENT HAD BEEN OPENED. AT THIS TIME JACOB AND DAVID SEARCHED THEIR VEHICLES AND FOUND NOTHING ELSE TAKEN. I ADVISED THEM OF THE PAPERWORK THAT WAS RECOVERED AND THEY ADVISED THAT IT HAD COME OUT OF THE RAV 4.
