On 2-22-23, I, Sgt. Trout spoke with Virginia Calles h/f dob 5-31-59 via telephone in reference to a known subject driving her vehicle without her permission and later wrecked the vehicle into a tree causing major damage. Virginia stated that on 2-12-22 during the evening hours, Anthony Adams w/m dob 2-23-82 was helping her employee Robert Ruiz h/m dob 1-25-80 deliver flooring to a residence located at 12918 FM 1878 in Nacogdoches. During this time Anthony left with the vehicle without her permission leaving Robert stranded. The vehicle was identified as a 2010 white in color GMC van bearing Texas license plate BZ5X277. Virginia found out the next morning from Robert as to what happened. Virginia stated that she did not wish to pursue criminal charges but only wanted the event documented at this time. Virginia provided me with Roberts phone number which was 936-221-4107.
