INFORMATIONAL REPORT:

ON 06-23-24 AT APPROXIMATELY 0530 HRS, NCSO RECIEVED A CALL FROM DEPUTY GOLF IN CHEROKEE COUNTY ABOUT A FEMALE, CALLE LOPEZ W/F 07-10-90, THAT THEY CONTACTED IN CHEROKEE COUNTY. THEY TOLD DEPUTIES THAT SHE WAS UNCOOPERATIVE AND THAT SHE WAS BEING TRANSPORTED TO NACOGDOCHES MEDICAL CENTER WITH INJURIES.

I RESPONDED TO NACOGDOCHES MEDICAL CENTER TO GET MORE INFORMATION FROM LOPEZ WHOM WAS IN THE ER AT THE TIME. SHE EXPLAINED TO ME THAT SHE AND HER EX-BOYFRIEND, DUSTIN HANAWAY W/M 01-01-86, LIVED TOGETHER IN NACOGDOCHES COUNTY TOGETHER AND BEEN DATING FOR A LONG PERIOD OF TIME. SHE SAID THAT THE DAY PRIOR SHE LEFT THE RESIDENCE DUE TO THE ABUSE SHE HAS ENDURED FROM HANAWAY. LOPEZ WENT AND STAYED WITH HER FRIEND IN SHADY GROVE, RANDY COX W/M 12-05-66. ON 06-22-24 HANAWAY CALLED HER AND EXPLAINED THAT HE WAS SORRY FOR THE WAY HE TREATED HER AND ASKED IF THEY COULD MEET TO TALK AT 4810 NORTH STREET, WALMART. AROUND 2100 HRS, WHILE LOPEZ WAS INSIDE WALMART, SHE MET HANAWAY AT THE COSMETIC SECTION WHERE THEY MADE UP, HUGGED AND KISSED. HANAWAY THEN TOLD LOPEZ THAT SHE HAD TO COME WITH HIM SO THEY COULD DO SOMETHING "IMPORTANT". LOPEZ AND HANAWAY WENT TO A BLACK NEWER STYLE TRUCK INTHE PARKING LOT AND LEFT WALMART. LOPEZ COULD NOT GIVE MUCH INFORMATION ON THE TRUCK, SHE EXPLAINED IT WAS NEWER, BIGGER, AND HAD BLACK LEATHER SEATS. SHE BELIEVES THAT THE TRUCK BELONGS TO A GUY NAMED "TRIP", WHOM LIVES IN CHEROKEE COUNTY.

AFTER THEY LEAVE THE PARKING LOT, THEY TRAVEL ON NORTH STALLINGS TOWARDS NW STALLINGS. LOPEZ COULD NOT EXPLAIN WHERE THEY WENT AFTER THAT. SHE REQUESTED THAT HANAWAY TAKE HER TO PICK UP HER DOG AT COX HOUSE. HANAWAY REFUSED AND THEN BEGAN PULLING HER HAIR IN AN AGGRESSIVE MANNER. THEY CONTINUED TO DRIVE AS LOPEZ BEGGED HANAWAY TO STOP THE VEHICLE. SHE COULD NOT EXPLAIN WHERE THEY DROVE TOO, AND COULD ONLY SAY THAT IT WAS AT A FOUR WAY INTERSECTION IN NACOGDOCHES COUNTY. THEY MADE A LEFT AT THE INTERSECTION AND HANAWAY CONTINUED TO YELL AT HER. HE TOLD HER THAT SHE WAS CRAZY AND THAT HER DOG WAS NOT IMPORTANT. THEY STOPPED ON A DARK ROAD, IN WHICH SHE COULD NOT GIVE DIRECTIONS TO, AND LOPEZ ATTEMPTED TO THROW THE KEYS OUT OF THE TRUCK. SHE WAS UNSUCCESSFUL. SHE SAID THAT SHE GOT OUT AND HANAWAY FOLLOWED HER AND STARTED HITTING HER IN THE HEAD. SHE GOT INTO THE DRIVER SEAT TO GET AWAY FROM HIM. HE THEN PULLED HER OUT OF THE VEHICLE BY HER FEET AND STARTED CHOKING HER WITH BOTH HANDS. HE DID IT ONCE, THEN STOPPED, THEN BEGAN CHOKING HER AGAIN AND SHE SAID SHE PASSED OUT. AT THIS POINT THEY ENDED UP BACK IN THE CAR AND SOMEWHERE IN CHEROKEE COUNTY CLOSE TO "TRIPS" HOUSE. SHE SAID SHE GOT OUT OF THE VEHICLE AND TRIED TO WALK AWAY AND HANAWAY TOOK HER PURSE FROM HER AND WENT IN THE OTHER DIRECTION. CHEROKEE COUNTY DEPUTIES THEN CONTACTED HER ON THE SIDE OF THE ROAD, GAVE HER A RIDE TO THE ALTO LIBRARY AND

THEN REQUESTED EMS FOR HER TO BE TAKEN TO THE HOSPITAL IN NACOGODCHES COUNTY.

IT SHOULD BE NOTED THAT THERE WERE GAPS IN LOPEZ'S STORY. SHE CLAIMED THAT SHE COULD NOT REMEMBER DETAILS OF WHAT TOOK PLACE. SHE ALSO STATED THAT SHE DID NOT WANT TO FILE ANY CHARGES AGAINST HANAWAY AND SHE WAS GOING TO GO COLORADO. LOPEZ WAS HESITANT TO GIVE ME ANY INFORMATION OR LEGITIMATE NAMES CLAIMING THAT SHE DID NOT WANT OTHER PEOPLE INVOLVED.

I NOTICED THAT LOPEZ HAD SOME FRESH WOUNDS ON HER RIGHT HAND THAT SHE CLAIMED TO BE BITE MARKS OR GRAB MARKS. THEY WERE RED AND FRESH. SHE HAD BRUISING AROUND HER LEFT TEMPLE ON HER HEAD AND MULTIPLE BRUISES ON HER FACE. THESE DID NOT APPEAR FRESH TO ME. SHE HAD BRUISING ON HER KNEE CAPS AND FEET. I PHOTOGRAPHED HER BODY AND ADDED THE PHOTOS TO THIS INCIDENT FILE. SHE WAS GIVEN A VICTIM OF ASSAULT FV INFORMATION CARD. ULTIMATELY THIS REPORT WAS CREATED TO CODUMENT THE ALLEGED FAMILY VIOLENCE THAT HAD OCCURRED THE NIGHT PRIOR IN NACOGDOCHES COUNTY. THIS WAS NOT A FOSTER HOME AND NEITHER PARTY IS MILITARY.
