NARRATIVE:

ON 8/29/24 AT APPROXIMATELY 1538 HOURS, DEPUTIES WERE DISPATCHED TO THE 7900 BLOCK OF NORTH STREET IN REFERENCE TO A DISTURBANCE IN PROGRESS. WHILE IN ROUTE DEPUTIES LEARNED THAT A FIREARM HAD BEEN BRANDISHED AND AN ASSAULT HAD OCCURRED. UPON ARRIVAL, THE SUBJECT WAS PERCEIVED TO BE ON NARCOTICS AND WAS ACTING EXTREMELY ERRATIC. DEPUTIES ATTEMPTED TO TALK TO THE SUBJECT, WHEN THE SUBJECT ASSAULTED ONE OF THE DEPUTIES. DEPUTIES HAD TO USE FORCE TO TAKE THE SUBJECT INTO CUSTODY.
