During the investigation, officers discovered that a female victim had been assaulted with a deadly weapon and unlawfully restrained in her apartment by her boyfriend over the past seven days. The male subject was identified as the boyfriend who assaulted her. He was located down the street from the apartment in possession of 1.03 grams of a controlled substance and 1.34 grams of a dangerous drug. He also appeared to have signs of assault, reportedly inflicted by locals who found him assaulting his girlfriend.
