## Investigation Narrative

Date, Time, Reporting Officer: 08/19/2025, 8:45 A.M., Officer Peterson

Description of the Incident: POCs PG2 &lt;1G DFZ (F3) 481.134(d)

On Tuesday August 19, 2025, I, Officer Holt, was radioed by Assistant Principal [REDACTED] in reference to a male juvenile student, [REDACTED] at the Nacogdoches High School, being in possession of a THC Vape. AP [REDACTED] handed me the suspected THC Vape and we walked to his office in room 120. In AP [REDACTED] office, he called [REDACTED] step-father to advise him of the situation and to come take custody of him. I then called Probation Officer Landry and he advised to release [REDACTED] to his guardian. AP [REDACTED] advised he saw [REDACTED] in possession of the vape in the boys restroom on the 200 hall of the Nacogdoches High School. AP [REDACTED] and I then walked back to my office in, A-12.

Officer Peterson began filling out the fingerprint form for [REDACTED] and took his fingerprints. While Officer Peterson was filling out that paperwork, I tested the suspected THC Vape with a MobileDetect Presumptive CBD/THC test kit and the kit showed positive for THC. I then weighed the vape on an uncertified scale and it weighed approximately 31.8 grams. Photographs of the the vape and test kit were taken and have been uploaded into the case for evidence.

After testing the THC Vape, [REDACTED] step-father, [REDACTED] came up to the school to take custody of [REDACTED] [REDACTED] came to my office and was very hostile and blaming officers and the school for Carrell being in possession of the THC Vape. [REDACTED] was still irritated and walked out before signing the Juvenile Referral form. All necessary paperwork has been filled out and will be attached with this report. [REDACTED] was referred to juvenile probation for being in possession of a THC Vape on school premises.
