On 08-22-2025 at 0730hrs I, Officer Peterson responded to Assistant Principal [REDACTED] office in reference to a student who was found to be in possession of a THC vape at the Nacogdoches High School (located at 4810 Appleby Sand Rd).

[REDACTED] advised that [REDACTED] had contacted him saying that the 100 hall boys bathroom "smelled like weed", York identified [REDACTED] as the last student that she had observed leaving said bathroom. [REDACTED] then searched the student and located the vape in his pocket.

Upon my arrival Officers Holt and Cook were already on scene and I observed a male student who was identified as [REDACTED], sitting in a chair and a vape was on the table in front of him. [REDACTED] advised that [REDACTED] had been located in the 100 Hall boy's bathroom and was found to be in possession of the vape in his pants pocket.

The vape was identified as a "HIGH IN THE ZONE" brand, "Mystery Blow Pop" flavored vape which had a total combined weight of 31.35g and tested positive for THC in a NIK Y test. The vape was sealed in evidence bag [REDACTED] and secured in evidence locker [REDACTED] of the NISD Police Department (located at 609 N Mound). [REDACTED] was placed under arrest at 0745hrs for HSC 481.134D, Possession of a controlled substance in a drug-free zone.

Holt, Cook and I escorted [REDACTED] to my office where I fingerprinted [REDACTED] on a Texas Department of Public Safety Juvenile Justice Reporting form. I contacted the Nacogdoches County Juvenile Probation office by phone. I was advised by Probation Officer Anthony Landry to release [REDACTED] to his guardian have them transport to their office for processing at their location (621 Harris St).

Officer Holt requested [REDACTED] to contact [REDACTED] s guardian and notify them of his arrest. Parents arrived a short time later and [REDACTED] was released to his guardian, [REDACTED] who was advised to go to the Juvenile Probation Office. A Nacogdoches ISD Juvenile Referral form, and a Juvenile Arrest/ Detention

Notification Form was completed (copies will be attached to this report).

A copy of this report will be forwarded to Juvenile Probation and the arrest, search, finger printing, and releasing to a guardian was recorded on my body worn camera in its entirety. No further police action is required at this time.
