Miscellaneous Incident Investigation Narrative

1. Incident description:

At approximately 0835, 01 August 2025, Officer KILLINGSWORTH was contacted via telephone by NISD Police Chief J. BARTON and advised that a motor vehicle accident had been reported to him via telephone and that it was located at the rear of the T. J. Rusk Elementary School in the drop-Off lane. KILLINGSWORTH responded to that location and found a white 2000 Ford F-150 pickup, Tx L/P JSX-0398, positioned across the lane and the front of the truck was setting inside the rock retaining wall. The rear truck tires were in the lane against the east curb, the front of the truck was elevated and off the ground by several inches as it lay inside the retaining wall. Both air bags had deployed within the truck, the driver was un-injured and seen walking around the truck and towards the arriving officer.

KILLINGSWORTH made contact with the driver, identified as 71-year-old PEDRO RAMIREZ LUNA (an employee of the District and assigned to the TJR facility) and established that he was not injured and did not seek or desire medical attention. When asked for identification, LUNA produced his Texas I/D card and his Immigration Card. LUNA was asked and denied having a Texas drivers license or any other drivers license. LUNA then explained to the officer that he was attempting to re-position his truck within the lane and as he did so, his foot slipped off the brake of the truck and slammed onto the accelerator, causing the truck to aggressively leap forward and into the retaining wall. Both air bags deployed and there was extensive damage to the front end of the truck as well as the retaining wall. Due to LUNA's broken English language, a phone call had already been made to his daughter and the registered owner of the vehicle. As LUNA was speaking with KILLINGSWORTH, the daughter/owner arrived, identified as 41-year-old ELVIRA ESPARANZA BENITEZ. BENITEZ confirmed that she was the registered owner of the truck and that the explanation that LUNA had given about the events as they had occurred. BENITEZ did produce the insurance on the truck which shows to be valid and also showed LUNA as an authorized driver of the vehicle also.

2. Premises location and description:

The Thomas J. Rusk Elementary School is a very large two-story historic structure located at 411 N. Mound Street, Nacogdoches, Texas. The front of the building faces East and the rear of the building faces west. The "drop-off" lane in question is located on the west side of the building and runs north/south parallel with the rear of the building. The raised retaining wall that was struck and severely damaged is located near the center of the rear of the building parallel to the traffic lane.

3. Other information:

The owner of the truck, BENITEZ, contacted Joey Ross Towing to have the truck towed to a residential location. Ross Towing arrived and removed the vehicle at about 0935, 01 August 2025. Additionally, no citation was issued to the driver LUNA due to (a) the incident taking place on private property and (b) LUNA was not seen driving the vehicle.
