On 10/27/2025 at approximately 4:01PM I Officer Ray was notified about a vape being located on a student. Once I made it to Mr. Durhams office I saw who was identified to me as Bethaniah Palacio (DOB-10/9/2025 SID-43536) with Mrs. Tubbs who stated that Mrs. Scott brought Palacio to her.

Mrs. Scott stated that another student came up to her during class and told her that he thought Palacio had a vape. Mrs. Scott called Palacio to her and asked her if she would show her what she had on her, and told her that they could go see Mr. Durham or Palacio could just show her. Palacio showed Mrs. Scott what she had in pockets and she did not have a vape on her person at the time. Mrs. Scott went back into the class and a student was holding Palacio ID case with a vape inside. Palacio had given the ID case to a student named Khyron Bell before showing Mrs. Scott her pockets. Mrs. Scott then walked Palacio to Mr. Durham's office where she found Mrs. Tubbs.

I contacted juvenile probation and they stated to release Palacio to her parents. Palacio mother who was identified to me as Karina Palacio arrived at the school were it was explained to her on what their next steps were. Karina signed the Juvenile referral form accepting custody of Palacio.

I Officer Ray tested the vape with a THC quick test and it tested positive. The THC vape was a gold Big Chief. The vape has been logged into a evidence locker 2. Photos have been uploaded into the case file.

The complainant stated that two dogs from the neighbor's property frequently attempt to approach her own dog. However, deputies advised they would make contact with the neighbor and recommend that she make an effort to restrain her dogs to avoid potential issues or harm to the animals. Deputies will pass this information along to the next shift for follow-up contact. The neighbor was described as residing in a brick house to the right of the complainant's residence, with two blue vehicles parked at the location.
