On October 28, 2025, at approximately 3:00 P.M. I, Officer Holt, was radioed to the nurses office at the Nacogdoches High School. Upon my arrival, I observed a female student, later identified as Brianna Evette McClelland (B/F DOB 09-04-2008), sitting in a chair in the nurses office and Assistant Principal Heath advised she was in possession of THC Vape. AP Heath advised that Mrs. Sutherland, a teacher at the Nacogdoches High School, contacted her in reference to McClelland. AP Heath stated Sutherland told her that McClelland came into her class room for 8th period smelling like the odor of marijuana and acting high. That statement gave AP Heath reason to search McClelland and when she did, she located a suspected THC Vape on her person. I looked at the suspected vape, a black in color Muha Meds Green Apple Elixir, and from my training and experience, I knew the vape to be a THC Vape.

I then took McClelland back to my office and waited for another officer to arrive to transport her to NLEC due to her being a female. While waiting for another officer to arrive, I explained to McClelland that she was under arrest for being in possession of a THC Vape on school premises. Once Officer Ray arrived, we secured McClelland in handcuffs and transported her to NLEC to book her in for Possession of Controlled Substance PG 2 <1g Drug Free Zone and then released her into the custody of the jail staff without incident.

I then tested the THC Vape on a Mobiledetect THC field test kit and the kit showed the vape tested positive for THC. I then weighed the vape on an uncertified scale and it weighed approximately 17.2 grams. Photographs of the THC Vape, weight and test kit were taken and have been uploaded into this case for evidence. Body camera footage was uploaded into the Motorola Server and has been attached to this case number. The THC Vape was placed in an evidence bag and was secured in Evidence Locker #1 at the NISD Police Department.
