On October 2, 2025 at approximately 1300 hrs the Principal at Fredonia Early Childhood Development 1326 S Fredonia St., Lindsey Turner WF 10-17-81 was called

to the front door of the school for a parent later identified as Deqesha Deckard BF 12-8-97. Deqesha was demanding to pick up her child but was refusing to identify herself by identification or date of birth. Deqesha then attempted to push through the door and placed her foot in the door to prevent it being closed. Mrs. Turner advised her that she had to close the door and that Mrs. Deckard was going against school safety measures. Deqesha said Mrs. Turner had five seconds to let her in or she was forcing her way in to get her child.

Officers Bob Killingsworth and Josh Griffin were called and responded to the school. Mrs. Deckard was calm upon arrival and was allowed to pick up her child after properly identifying herself. She then left the property.

Today on 10-3-25 I Sgt. Read contacted Deqesha Deckard and issued her a CT warning for Fredonia Pre K. She was advised that she could not come inside the school building but could pick up or drop off her child through the drive through lane.
