On October 7th, 2025, at approximately 12:50 P.M., I, Officer Holt, was radioed by Secretary Stacy Light to come to her office. I arrived and observed a female student, later identified as Catherine Wanack (W/F DOB 07-15-2009), sitting in a chair explaining that she thought she observed a pistol sitting behind a student's chrome book computer. I asked Wanack if she knew the student's name and she stated no, but advised he was a Hispanic male wearing a black shirt and black pants. She also advised he was in her class and that was in room 505. Officer Russell, Officer Peterson and I, all went to room 505 and located two Hispanic males who were wearing those clothes. We took both students into the hallway and due to the circumstances of one of them potentially having a firearm on their person or in their backpack, I instructed both students to put their backpacks on the ground and I began searching one of them and Officer Peterson began searching the other. In the backpack I was searching, I located a replica black handgun that had an orange tip on the barrel indicating it was a fake handgun from my training and experience. I then asked the student his name and he advised it was, Ever Armando Lopez-Ramos. The student that Officer Peterson was searching his backpack, he did not find anything, was sent back to class. Assistant Principal Kristen Heath took Lopez-Ramos to her office and handled his discipline within the school. I gave the replica handgun to AP Heath to release to his parent.
