Incident Report:

On 10/08/25 at approximately 0740 hrs, I, Officer Griffin, was on duty at 609 N. Sanders St. (Brooks Quinn Jones Elementary School), assisting staff members with the Kindergarten-2nd grade car drop-off line at the main entrance of the building.

While standing out front, I observed a white mid-size SUV stop in front of Mrs. Huss (Art Teacher). I recognized the vehicle and the occupants exiting the car due to assisting staff with several behavioral issues in the past. After two of the 3 students exited the car, I observed that Ayden Belin B/M 09/02/18 (Student ID # 48650) was refusing to get out of the car. I walked towards the back passenger door and

overheard Mrs. Huss politely telling Ayden to get out of the vehicle so that he could go and eat breakfast. After multiple failed attempts, I overheard Ayden tell Mrs. Huss, "to leave me alone, I'm not going anywhere with you Bitch." Mrs. Huss stepped away from the car, and I proceeded to try to convince him to exit the vehicle.

As I leaned inside the vehicle, I observed Ayden sitting in the 3rd row section of the vehicle, fuming with anger. I informed him that we do not speak to staff members in that manner and instructed him to get out of the vehicle and go to class. He continuously refused and began yelling at me in anger, telling me to leave him alone. I then proceeded to grab his hand in an attempt to get him out of the vehicle, and he continued to refuse. Ayden then made the following statement toward me: "Don't touch me, you bitch ass nigger, or I will fucking kill you." After the statement was made, I stepped away from the vehicle and called for the admin and the behavior support specialist to intervene. After several minutes, the administration was able to convince Ayden to exit the vehicle on his own accord and without incident. Let it be known that during past incidents with Ayden, Lakeyna Sims B/F 05/27/87 (Ayden's mother) has personally requested me to assist her or staff in getting Ayden out of the vehicle. During this incident, she sat motionless and never attempted to assist the staff in getting Ayden out of the vehicle.

Upon completion of my car line arrival duties, I returned inside and informed AP Thompson, who is in charge of behavioral incidents, of Ayden's actions earlier in the morning. Due to Ayden's age, no criminal charges will be sought, and discipline will be handled by the administration.

At this time, the incident is considered closed, and no further law enforcement action is needed.
