Mrs. McKenzie brought Davis to my office were I Officer Ray was able to test the vape with a THC quick test which came back positive for THC. The THC vape weighted at 29.51 Grams and will be placed into evidence locker 2.

Mrs. McKenzie stated that another student who was identified to me as Khloe Moore (DOB-10/27/2011 SID-44752) reported it. Moore wrote a written statement advising that after lunch she walked to class and they go to the restroom after putting down their things. Moore stated that she went to the restroom when she saw Davis and her friends passing a vape or weed pen then Moore used the restroom and after Moore was done Davis started talking to her, when she was washing her hands. Moore stated that she left the restroom and told the teacher who then told her to go tell Mrs. Toledo and she did.

Mrs. McKenzie stated that she went and got Davis from class and brought her to an office where she asked Davis if she had anything on her she wasn't supposed to have and Davis stated yes and attempted to look for it herself. Mrs. McKenzie searched Davis's backpack where she located One gold coast clear blue and pink THC vape along with two THC vape boxes and Wrappers. The second THC vape was not located on Davis.

Pictures of the THC vape have been uploaded into the case file and the THC vape has been placed into evidence locker 2 Juvenile probation has been contacted and

Davis's mother who was identified to me as Andrea Galvan was contacted and Davis was released into her custody.
