On 4-20-26 deputies were dispatched to the 15000 blk of FM 226 in reference to a fire assist call. While in route dispatch advised that numerous calls came in reporting explosions. A short time later dispatch advised that a drilling rig in Etoile had caught fire and blew up. Upon arrival deputies made contact with the rig supervisors and made sure everyone was accounted for and then made arraignments to start evacuating residents located in close proximity to the incident. Deputies returned to service after the fire stayed confined to the oil well pad and appropriate oil field services arrived on scene to take care of the fire.
