Deputies were dispatched to the 500 block of CR 785 in reference to a reported disturbance involving a subject who had allegedly made suicidal statements during a verbal argument with his wife. Upon arrival, deputies made contact with both parties involved and separated them in order to conduct interviews. During the investigation, the male subject was identified and interviewed regarding the statements he allegedly made. The male subject advised deputies that he did not intend to harm himself or anyone else. The subject stated he was upset during the argument with his wife and made the statement out of anger. The subject denied having any thoughts of self-harm or any desire to cause harm to others. Deputies did not observe or hear anything during their investigation that would indicate the male subject was an immediate danger to himself or others. The subject was offered medical assistance but refused any medical treatment. The subject was advised that Nacogdoches County Sheriff's Office Mental Health Deputies would follow up with him at a later date and time. No criminal offense was determined to have occurred during this incident.

Both parties were advised to separate for the remainder of the day to allow the situation to de-escalate. Deputies cleared the scene and returned to service.
