UPON ARRIVAL, DEPUTIES OBSERVED A TRUCK TRACTOR PULLING AN OVERSIZED LOAD THAT WAS STOPPED ON THE ROADWAY. THE ESCORT VEHICLE OPERATORS ADVISED DEPUTIES THAT THE TRUCK TRACTOR HAD SLIPPED A GEAR WHILE ATTEMPTING TO MANEUVER UP THE HILL, CAUSING THE TRUCK TO LOSE MOMENTUM AND BECOME UNABLE TO GENERATE ENOUGH POWER TO CONTINUE UP THE ROADWAY.

THE DRIVER ADVISED DEPUTIES THAT THE COMBINATION OF THE TRUCK TRACTOR AND OVERSIZED LOAD WAS WEIGHING APPROXIMATELY 950,000 POUNDS.

A HEAVY-DUTY WRECKER SERVICE WAS CONTACTED TO ASSIST WITH MOVING THE TRUCK TRACTOR AND OVERSIZED LOAD. THE WRECKER ARRIVED AND ASSISTED WITH CLEARING THE VEHICLE FROM THE ROADWAY. ONCE THE ROADWAY WAS CLEARED AND TRAFFIC WAS NO LONGER OBSTRUCTED, DEPUTIES RETURNED TO SERVICE.
